Capital Credit Union is a **Not for Profit**, member-owned financial services co-operative, based on a philosophy that allows “**affordable and accessible financial services for everyone**”.

Like all credit unions, **Capital believes in the creation of wealth, not debt!** As a result, all surpluses are shared with our members in the form of an annual dividend on their savings (surpluses are calculated once statutory reserves have been met).

History

Capital Credit Union was established in 1989, and today has over 18,000 members. Capital is presently supported by a total of 50 sponsoring organisations. These include the Scottish Executive, Scottish Parliament, City of Edinburgh Council, West Lothian Council, East Lothian Council, Midlothian Council, Scottish Borders Council, Lothian University Hospitals NHS Trust, and Scottish Fire and Rescue Service.
